There will be no seeding for Tot and Novice, and no reseeding on Sunday.

NOVICE: **NOVICE WRESTLER ONLY:** The wrestler has no experience before November 2010, with the exception of Tot, including no practices and league matches. Anyone who wrestled at all last season or during the summer is not eligible for the novice division. Any breach of this policy WILL result in disqualification. All Novice wrestlers will receive a participation medal. **All Novice Wrestlers Will BE GUARANTEED TWO MATCHES.**
