**Format:**

- \* 8 teams - 4 mats.
- \* 7 Guaranteed matches.
- \* Every team will wrestle each other.
- \* Periods will be 2-2-2 with certified referees.
- \* 4 matches on Saturday and 3 matches on Sunday.
- \* College Out of bounds rule will be in effect.

**Weigh Ins:** Saturday November 13th from 8:00 - 9:00 am

**Weight Classes:** 16 weight classes. Actual Weight classes will be:  
98, 103, 108, 114, 119, 125, 130, 135, 140, 145, 152, 160, 172, 189, 215, 285

**Scheduled Match Times:**

Saturday: 10:00, 12:00, 2:00 & 4:00

Sunday: 10:00, 12:00, 2:00

**Awards:** There will be a team trophy for the 1st and 2nd place teams and each individual weight class will crown a weight class champion who will get a LI Wrestling Tournament Pre-Season Dual Meet Champion Tee shirt.

**Scoring** Team placement will be determined by:

1. Overall Record.
2. Head to Head Competition.
3. Overall team points scored in the 7 matches.

**Roster:** Teams can bring an unlimited number of wrestlers.

**Free Agents:** If teams need to fill weight classes there will be a list of available free agents for each weight class online.

**Cost:** \$650 per team for 7 matches.  
Each team is responsible for bringing 1 table helper for each day.

RELEASOR EXPRESSLY AND VOLUNTARILY ASSUMES ALL RISK OF PERSONAL INJURY, PERMANENT, TEMPORARY, TOTAL OR PARTIAL DISABILITY, DISFIGUREMENT, PARALYSIS AND ANY OTHER LOSSES OR DAMAGES TO PERSON OR PROPERTY OR DEATH, sustained while participating in, attending, preparing for or traveling to and from any USA Wrestling sanctioned event, meet, practice or activity, including the risk of PASSIVE OR ACTIVE NEGLIGENCE OF THE RELEASEES, or hidden, latent or obvious defects in the facilities or equipment used. 3. Releasor acknowledges and fully understands that each participant in any USA Wrestling sanctioned event, meet, practice or activity, including Releasor, will be engaging in activities that involve risk of serious injury, including permanent, temporary, total or partial disability, disfigurement, paralysis and other losses to person or property, including death, and that severe social and economic losses may also result not only from Releasor's own actions, inactions or negligence, but also from the actions, inactions or negligence of others notwithstanding the rules of play or the condition of the premises or of any equipment used. Furthermore Releasor acknowledges and fully understands that there may be other associated risks with such activities which are not known or not reasonably foreseeable at this time.
